- 4. Installation of CCTV Cameras: In line with security and surveillance measures, CCTV cameras have been strategically installed in various areas of the campus to deter potential ragging incidents and ensure accountability.
- 5. Anti-Ragging Warning in the Institutional Prospectus: The college's prospectus prominently features a stern warning against engaging in ragging activities, emphasizing the institution's zero-tolerance stance.
- Anti-Ragging Posters: Eye-catching posters conveying anti-ragging messages and promoting a culture of mutual respect and dignity adorn the college premises, serving as constant reminders of the consequences of ragging.
- 7. Awareness during Admission: During the admission process, incoming students are sensitized to the hazards of ragging and educated on the college's anti-ragging policies and disciplinary measures.
- 8. Anti-Ragging Undertaking: As per UGC regulations, all students are required to sign an anti-ragging undertaking, affirming their commitment to abiding by the college's anti-ragging norms.
- 9. Sensitization during Orientation Programme: Comprehensive orientation programs for new students include sessions on ragging awareness, emphasizing the importance of mutual respect and tolerance, and educating students on the consequences of engaging in ragging.

- 10. Introduction of Freshers with the Committee: Freshers are introduced to the members of the Anti-Ragging Committee, fostering a sense of familiarity and accessibility for students seeking assistance or guidance.
- 11. Regular Interaction and Inspections: The Anti-Ragging Committee maintains regular interaction with students and conducts periodic inspections to ensure compliance with anti-ragging protocols and address any emerging concerns promptly.
- 12. Access to Principal: Students have unrestricted access to the college Principal, who serves as a key point of contact for addressing ragging-related grievances and concerns, further ensuring a supportive and responsive institutional framework.
